BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. ROYAL BUSINESS MACHINES, 2. SAN SIERRA BUSINESS SYSTEMS, 3. COPTec INC., 4. INTERNATIONAL BUSINESS MACHINES and 5. XEROX CORPORATION are hereby accepted and the City Manager is hereby authorized to execute contracts for the RENTAL OF COPIERS AND DUPLICATORS, and copier supplies as may be required per prices on file in the Purchasing Department, with an option to rent additional equipment of the same model, at the same rate, as follows:

1. ROYAL BUSINESS MACHINES - for Items 5, 6, 9, 11, 26 and 29; for a period beginning July 1, 1983 or date of installation, whichever is later, through June 30, 1984; terms net, plus sales tax.
2. SAN SIERRA BUSINESS SYSTEMS - for Items 1, 3, 7, 8, 25 and 28; for a period beginning July 1, 1983 or date of installation, whichever is later, through June 30, 1984; terms net, plus sales tax.
3. COPTec INC. - for Item 2; for a period beginning July 1, 1983 through June 30, 1984; terms net, plus sales tax.
4. INTERNATIONAL BUSINESS MACHINES - for Items 14, 15, 16, 17, 20, 21, 22 and 23; for a period beginning July 1, 1983 or date of installation, whichever is later, through June 30, 1984; terms net, plus sales tax.
5. XEROX CORPORATION - for Items 4, 12, 13, 18, 19, 24 and 27; for a period beginning July 1, 1983 or date of installation, whichever is later, through June 30, 1986; with the City's option to terminate any item June 30, 1984 or June 30, 1985 should funds not be appropriated; terms net, plus sales tax.
