BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

MISSION BEACH PARK PHASE I DEVELOPMENT.

BE IT FURTHER RESOLVED, that the total expenditure of \$1,115,583.00, not to exceed \$385,583.00 from Capital Outlay Fund 30245 and \$730,000.00 from Transient Occupancy Tax Fund 10223, CIP No. 23-101 MISSION BEACH PARK - Development, of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
