RESOLUTION NUMBER R- 258750

Adopted on JUN 27 1983

WHEREAS, a certain offsite water easement on San Diego Gas & Electric Company property was acquired in connection with the development of Governor Drive Business Park Unit 1; and

WHEREAS, said water easement will no longer serve the public purpose for which it was acquired; and

WHEREAS, the City has no present or prospective public use for a portion of the water easement, and the City Manager has recommended that the City abandon its interests therein; and

WHEREAS, the water easement was acquired at no cost and HARRY L. SUMMERS, INC., a California corporation, has paid all City costs in connection with processing the matter of quitclaiming the easement; and

WHEREAS, the processing costs of the abandonment will be the consideration for the sale of the City's rights; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 258750 - 1, quitclaiming to SAN DIEGO GAS & ELECTRIC COMPANY, a California corporation, all the City's right, title and interest in a portion of a water easement, as more particularly described in

said quitclaim deed.

2. That the City Clerk shall cause the quitclaim deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
