That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY for the cooperative installation of rubber railroad crossing material at the railroad grade crossing on 32nd Street (PUC No. 2-271.0), under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- **258781**.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$41,000 from CIP 64-004 "Railroad Warning Devices - Annual Allocation," Capital Outlay Fund 30245, is hereby authorized, for the purpose of purchasing rubber railroad crossing material and any work related to crossing gates associated with the installation of the rubber crossing material.
