WHEREAS, it has been determined that comprehensive pre-employment physical exams are essential for reducing future losses from industrial injuries and also for providing baseline information to use in defending claims against the City which allege industrially-caused disabilities; and

WHEREAS, the City desires to obtain medical services in the form of pre-employment physical examinations and other additional medical services as may be required; and

WHEREAS, the Industrial Medical Centers has provided this service in a most acceptable fashion during fiscal year 1982-83 and is deemed best qualified to continue such service for the forthcoming year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Personnel Director be and he is hereby authorized and empowered to execute, for and on behalf of said City, a FIRST AMENDMENT TO AGREEMENT with INDUSTRIAL MEDICAL CENTERS to provide pre-employment physical examinations and other medical services, by extending the term for a one-year period ending June 30, 1984, of that certain base agreement on file in the

office of the City Clerk as Document No. RR-256862, dated July 26, 1982, under the same terms and conditions, at a total cost not to exceed \$85,450.
