
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

3. That the expenditure in the sum of \$70,000 from Capital Outlay Fund CIP 36-030.0 (Southeastern Division Police Station) be and it is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
