BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized to extend the current agreement with MODULAIRE INDUSTRIES as authorized by Resolution No. 254456, adopted on June 15, 1981 and amended by Resolution No. 258399, adopted on May 9, 1983, for RENTAL OF FOUR (4) EACH MODULAR BUILDINGS for an additional one (1) year period beginning July 1, 1983 through June 30, 1984, per the original bid prices on file in the Purchasing Department, for a total annual cost of \$14,640.00; terms net 30 days, plus sales tax, with an option to renew contract for four (4) additional one (1) year periods with the annual price escalation not to exceed 3% of the original bid prices; with an option to cancel rental of any one (1) building upon thirty (30) days notice.
