
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

3. That the expenditure in the sum of \$37,500 in 1983 CDBG matching funds (Fund 18519, Dept. 5714, Org. 1407) for the above program be and it is hereby authorized.
