

RESOLUTION NUMBER R- 258791

Adopted on JUN 27 1983

WHEREAS, Section 64.32 of the San Diego Municipal Code provides that sewer service charges may be established by resolution of the City Council upon the giving of ten (10) days' notice of intention to establish, amend or increase said charges; and

WHEREAS, said notice has been given by posting the intention to increase said charges by the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follow:

That pursuant to Section 64.32 of the San Diego Municipal Code the following sewer service charges are established:

(1) The domestic sewer service charge for each single family dwelling unit serviced by a separate water meter shall be six dollars and thirty-three cents (\$6.33) per month.

(2) The monthly sewer service charge for all premises, other than single family dwellings serviced by separate water meters shall be at the rate of forty-five cents (\$.45) per hundred cubic feet of water usage by such premise, but in no case less than a minimum charge of six dollars and thirty-three cents (\$6.33) per month.

BE IT FURTHER RESOLVED, that this resolution shall be effective and in force on the first day of July, 1983.
