

RESOLUTION NUMBER R- 258792

Adopted on JUN 27 1983

WHEREAS, Section 64.35 of the San Diego Municipal Code provides that minimum sewer capacity charges may be established by resolution of the City Council upon the giving of ten (10) days' notice of intention to establish, amend or increase said charges; and

WHEREAS, said notice has been given by posting the intention to increase said charges by the City Clerk, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to Section 64.35 of the San Diego Municipal Code, the following minimum sewer capacity charge is established:

A minimum capacity charge of six hundred and thirty-six dollars (\$636.00) per single family unit or equivalent shall be paid. This charge shall be subject to simple interest of six percent (6%) from the effective date of this resolution, to and including that date the charge is paid.

In those areas of the City where a capacity charge in the form of area charges as established by Council resolutions, or taxations of special assessment districts

excluding 1911 and 1913 Act assessment districts results in a payment to the City totaling more than six hundred and thirty-six dollars (\$636.00) per single family living unit or its equivalent, no new capacity charge shall be imposed by this resolution. However, charges imposed due to reimbursable agreements entered into by the City shall be collected where applicable in every case.

BE IT FURTHER RESOLVED, that this resolution shall be effective and in force on the first day of July, 1983.
