APPROVING MAP OF
RESUBDIVISION OF MESA RIM INDUSTRIAL PARK

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Douglas C. Paul, a registered Civil Engineer, entitled "RESUBDIVISION OF MESA RIM INDUSTRIAL PARK, being a subdivision of Lots 1 through 21, inclusive of Mesa Rim Industrial Park, in the City of San Diego, County of San Diego, State of California, according to Map thereof NO. 10537, filed in the office of the County Recorder of San Diego County on December 14, 1982, together with Flanders Drive, Mesa Rim Road, Canyon Ridge Road and Mesa Ridge Road as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Flanders Drive, Mesa Rim Road, Flanders Court, Mesa Ridge Road and Mesa Ridge Court; and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1 and 2 of the Owner's


Certificate, as shown on this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; and that those easements listed in paragraphs 1 and 2 of the Owner's Certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
