RESOLUTION NUMBER R- 258807
Adopted on JUN 28 1983

WHEREAS, a certain drainage easement was acquired as an offsite requirement for the development of the subdivision known as Mesa Rim Industrial Park; and

WHEREAS, said subdivision is being resubdivided and the drainage easement has never been used and is no longer needed; and

WHEREAS, the City has no present or prospective public use for the drainage easement, and the City Manager has recommended that the City abandon its interests therein; and

WHEREAS, the drainage easement was acquired at no cost and all City costs in connection with processing the matter of quitclaiming the easement have been paid; and

WHEREAS, the processing costs of the abandonment will be the consideration for the sale of the City's rights; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 258807, quitclaiming to GENSTAR DEVELOPMENT INC., a New York corporation, all the City's right, title and interest in a portion of the drainage easement, as more particularly described

in the quitclaim deed.

2. That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
