RESOLUTION OF INTENTION TO LEVY AND COLLECT ASSESSMENTS ON THE SCRIPPS-MIRAMAR RANCH LIGHTING AND LANDSCAPE MAINTENANCE DISTRICT NO. 1 AND TO ANNEX THE SCRIPPS-MIRAMAR RANCH LIGHTING AND LANDSCAPE MAINTENANCE DISTRICT NO. 2 TO THE SCRIPPS-MIRAMAR RANCH LIGHTING AND LANDSCAPE DISTRICT NO. 1.

BE IT RESOLVED, that the Council of The City of San Diego proposes and intends to annex Scripps-Miramar Ranch Lighting and Landscape Maintenance District No. 1 to Scripps-Miramar Ranch Lighting and Landscape Maintenance District No. 2 and to levy and collect assessments to pay the cost of maintenance of all trees, shrubs, plants, etc., planted or placed within the open space areas as designated, located within the boundaries of the consolidated district, hereinafter described, in the City under the provisions of the San Diego Maintenance District Procedural Ordinance of 1975, Sections 65.0201 through 65.0222 of the San Diego Municipal Code, the Landscaping and Lighting Act of 1972, California Streets and Highways Code section 22500, et seq. Such annexation and maintenance being more particularly described as follows:

Section 1

DESCRIPTION OF MAINTENANCE

The proposed landscape maintenance consists in general of the following:

a. Irrigation, fertilization and shaping of trees and shrubs;

- b. Removal of weeds, trash and litter:
- c. Replacement of dead or diseased trees and shrubs;
- d. Repair of equipment and facilities;
- e. Pest control;
- f. Trail maintenance.

The proposed street light standard maintenance consists in general of the following:

- a. Painting
- b. Structural repair as necessary

The maintenance shall be for a period commencing on July 1, 1983, and ending on June 30, 1984.

Section 2

DESCRIPTION OF THE ANNEXATION

The Scripps-Miramar Ranch Landscape and Lighting
Maintenance District No. 2 was organized by City Council
Resolution R-250048 on August 14, 1979. It is proposed that the
Scripps-Miramar Ranch Lighting Landscape and Lighting
Maintenance District No. 2 as described in the map consisting of
eight (8) sheets on file in the office of the City Clerk as
document No.768717 be annexed to and become a part of the
Scripps-Miramar Ranch Lighting and Landscape District No. 1. No
changes are proposed in the total area encompassed by the two
districts. This annexation is only for the purpose of
administrative convenience.

Section 3

DESCRIPTION OF MAINTENANCE DISTRICT

The expenses of the contemplated maintenance hereinbefore mentioned are made chargeable upon the district hereinafter

district benefited by the maintenance and to be assessed to pay the costs and expenses thereof. The district is described as follows:

included within the exterior boundary lines of the map designated as "Scripps-Miramar Ranch Landscape and Lighting Maintenance District No. 1," consisting of fifty-eight (58) sheets and filed in the office of the City Clerk under Document No. 7687/8 excepting therefrom all public streets, pubic lands, roads, alleys, avenues and highways. Reference is hereby made to the map for a further full and more particular description of the maintenance district and the map so on file shall govern for all details as to the extent of the maintenance district.

Section 4

ASSESSMENT OF COST AND EXPENSE

It is proposed to assess the total amount of maintenance costs of the district, plus the incidental expenses thereto, less a City contribution of \$25 per acre of open space lands to be maintained, to all the real property within the district in conformance with the provisions of the San Diego Maintenance District Procedural Ordinance of 1975 and in proportion to the estimated benefits from the maintenance to be received by the individual parcels of real property.

The Council may order a portion of the costs of maintenance to be paid by the City from appropriate funds.

Such protest, if any, must be in writing and must contain a description of the property in which each signer thereof is interested, sufficient to identify the same and shall be delivered to and filed with the City Clerk at a time no later

than the hour set for the hearing.
