RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO PROVIDING FOR THE SALE OF 1983 TAX ANTICIPATION NOTES

WHEREAS, the Council of The City of San Diego, by proceedings duly had and taken, has authorized the issuance of \$34,000,000 principal amount of City of San Diego 1983 Tax Anticipation Notes (the "notes") and further duly authorized the sale of the notes at public sale to the highest bidder therefor; and

WHEREAS, notice of the sale of the notes has been duly given and the following bids for the notes were and are the only bids received, to wit:

Crocker National Bank	\$2,030,310.56
Bank of America N.T. & S.A.	\$2,040,133.22
Citicorp Capital Markets Group	\$2,051,697.78

AND WHEREAS, the bid of \$2,030,310.56 of Crocker National Bank is the highest bid for the notes, considering the interest rate specified and the premium, if any, offered;

NOW, THEREFORE, the Council of The City of San Diego hereby finds, determines, declares and resolves as follows:

Section 1. Said bid of Crocker National Bank for the notes


is hereby accepted and the City Treasurer is hereby authorized and directed to deliver the notes to said purchaser thereof upon payment to the City Treasurer of the purchase price, to wit: The par value thereof and a premium of \$ 245.00, together with accrued interest thereon to date of delivery, the notes to bear interest at the rate of six and twenty-five one hundredths percent (6.25%), payable at the maturity of the notes, and to be of the denominations as specified by said purchaser thereof.

Section 2. All bids except said accepted bid are hereby rejected and the City Clerk is hereby directed to return to the unsuccessful bidders their several checks accompanying their respective bids.

Section 3. The City Clerk is hereby directed to cause to be prepared a sufficient number of notes, said notes to show on their face that the same bear interest at the rate aforesaid.
