

RESOLUTION NUMBER R-258850

Adopted on JUL 11 1983

WHEREAS, drainage, flowage and water easements were acquired for an earlier development of Miramar Woods; and

WHEREAS, the present development of the property requires that said easements be abandoned and that a deed for sewer, water, drainage and emergency vehicle access easements be accepted; and

WHEREAS, the City has no present or prospective use for the easements and the City Manager has recommended that the City abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City of San Diego, by this resolution, does hereby abandon whatever right, title or interest it may have in the drainage, flowage and water easements in Lots 1 and 2 of Miramar Woods, Map No. 10234, as more particularly shown on Drawing No. 20752-1-D which is by this reference incorporated herein and made a part hereof.


2. That the acceptance by the City Manager of that deed of BREHM COMMUNITIES, a California corporation, executed in favor of The City of San Diego, bearing date of April 27, 1983, conveying to said City sewer, water, drainage and emergency vehicle access easements in Lots 1 and 2 of Miramar Woods, Map No. 10234, as more particularly described in the deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 258850 , is hereby approved.

3. That the City Clerk shall cause the deed and a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
