2. That the district will be for maintenance purposes only and the district proposes no construction of facilities at this time.

3. That the City Manager is hereby authorized to initiate proceedings for the formation of said Landscape and Lighting Assessment District pursuant to the Landscape and Lighting Act of 1972 (Sections 22500, et seq., Streets and Highways Code) and the San Diego Maintenance District Procedural Ordinance of 1975 (Sections 65.0201, et seq., San Diego Municipal Code), said district shall be known and designated as the Coronado View Landscape and Lighting Maintenance District.
