RESOLUTION OF INTENTION TO LEVY AND COLLECT
ASSESSMENT ON THE SAN DIEGO STREET LIGHTING
MAINTENANCE DISTRICT NO. 1.

BE IT RESOLVED, that the Council of The City of San Diego proposes and intends to levy and collect assessments necessary to provide energy, maintenance, improvements, and incidental costs required to operate street lights within the SAN DIEGO STREET LIGHTING MAINTENANCE DISTRICT NO. 1, for the period July 1, 1983 through June 30, 1984, under the provisions of the San Diego Maintenance District Procedural Ordinance of 1975, Sections 65.0201 through 65.0222 of the San Diego Municipal Code, Landscaping and Lighting Act of 1972, California Streets and Highways Code section 22500, et seq.

Pursuant to the San Diego Maintenance District Procedural Ordinance of 1975 (Chapter 6, Article V, Division 2 of the San Diego Municipal Code) the City engineer has submitted his report relative to the estimated energy, improvement, and maintenance costs for Fiscal Year 1984 of the San Diego Street Lighting Maintenance District No. 1. Said report contains a full and detailed description of the improvements, the boundaries of the assessment district and the proposed assessments upon assessable lots and parcels of land within the district and said report is on file in the office of the City Clerk as Document No.

RR-258859.

BE IT FURTHER RESOLVED, that the maps showing the parcels to be assessed shall be amended at the time of the hearing to provide for certain recent lot consolidations and lot splits, and annual changes in certain individual lights.

BE IT FURTHER RESOLVED, that the proposed maintenance includes the supplying of energy to street lights, replacing lamps and other glassware, and the periodic cleaning and painting of standards. Improvements consist of converting all incandescent and mercury vapor lights to high pressure sodium vapor lights.

BE IT FURTHER RESOLVED, that this Council does further propose, in connection with the aforesaid maintenance district proceedings, to enter into a new contract with the San Diego Gas & Electric Co. for the furnishing of electrical energy and switching for the period July 1, 1983 through June 30, 1984. Said contract will make provision for the San Diego Street Lighting Maintenance District No. 1 and said contract is on file in the office of the City Clerk as Document No. RR-258858

BE IT FURTHER RESOLVED, that notice is hereby given that on JULY 26, 1983 at 2:00 p.m. in the Council Chambers of the City Administration Building, The Charles C. Dail Concourse, 202 "C" Street, in the City of San Diego, California, is the day, hour and place for the hearing when any person interested may object to the proposed improvements or maintenance for the aforesaid territory, the amount of the assessment, or the awarding of the contract. Failure to make objection at that time shall be deemed to be a waiver of all objections and shall operate as a bar for any claim for damages.

Such protests, if any, must be in writing and must contain a description of the property in which each signer thereof is interested, sufficient to identify the same, and shall be delivered to and filed with the City Clerk at a time no later than the hour set for the hearing. No other protests shall be considered.
