RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ORDERING REORGANIZATION, "MISSION GORGE REORGANIZATION NO. 2."

WHEREAS, pursuant to the District Reorganization Act of 1965, commencing with Section 56000 of the Government Code, preliminary proceedings for reorganization consisting of six changes of organization, being an annexation to The City of San Diego, a detachment from the City of Santee, a detachment from the Padre Dam Municipal Water District, a detachment from the San Diego County Flood Control District - Zone 2, a detachment from the Santee Fire Protection District, and a detachment from County Service Area No. 69 were initiated by the City of San Diego on May 10, 1982, by filing a petition of application with the Local Agency Formation Commission in the County of San Diego; and

WHEREAS, the executive officer of the Local Agency
Formation Commission has filed a report relative to said
proposed reorganization, which report has been reviewed and
considered by the Local Agency Formation Commission; and

WHEREAS, on June 6, 1983, the Local Agency Formation

Commission adopted Resolution No. RO82-13 (attached hereto as

Exhibit 1), and thereby approved the proposed reorganization and authorized The City of San Diego to initiate and conduct proceedings for the proposed reorganization in compliance with

Resolution No. RO82-13, without notice and hearing, without an election, and pursuant to Government Code Section 56430 et seq.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that each of the changes in organization contained in the proposal for reorganization is ordered without notice and hearing and without an election pursuant to Government Code Section 56439.5. The changes of organization consist of:

- 1. Annexation of the territory described in Exhibit A, which is attached to Exhibit 1, to The City of San Diego.
- 2. Detachment of the territory described in Exhibit A, which is attached to Exhibit 1, from the City of Santee.
- 3. Detachment of the territory described in Exhibit A, which is attached to Exhibit 1, from the Padre Dam Municipal Water District.
- 4. Detachment of the territory described in Exhibit A, which is attached to Exhibit 1, from the San Diego County Flood Control District Zone 2.
- 5. Detachment of the territory described in Exhibit A, which is attached to Exhibit 1, from the Santee Fire Protection District.
- 6. Detachment of the territory described in Exhibit A, which is attached to Exhibit 1, from County Service Area No. 69.

BE IT FURTHER RESOLVED, that the City Clerk is directed to send to the Local Agency Formation Commission of the County of San Diego, six certified copies of the resolution approving the boundary change and six copies of the legal description of the boundaries.

WHEREAS, a petition of application was submitted to this Commission for reorganization of territory including annexation to the City of San Diego and detachments from the City of Santee, Padre Dam Municipal Water District, the San Diego County Flood Control District - Zone 2, the Santee Fire Protection District and CSA #69, which petition was certified sufficient by the Executive Officer on January 31, 1982; and

WHEREAS, the territory proposed for reorganization is as described in the application on file with the Local Agency Formation Commission; and

WHEREAS, all owners of land have consented in writing to the reorganization; and

WHEREAS, the Executive Officer of the Commission has filed his report on said reorganization, which report was received and considered by the Commission;

NOW THEREFORE, BE IT RESOLVED, that this Commission hereby finds, determines, and orders as follows:

- (1) The Commission certifies that it has reviewed and considered the information contained in the EIR prepared by the City of San Diego.
- (2) The Commission adopts the Environmental Findings required by Section 15088 of the State CEQA Guidelines for each significant impact identified by the EIR, as stated on Exhibit "B" attached hereto.
- (3) The Commission hereby approves the reorganization with modified boundaries, as described in Exhibit "A" attached hereto, subject to the following conditions:
 - a) The territory shall be concurrently detached from Padre Dam Municipal Water District Improvement Districts A and C.

(4) The boundaries of the territory as described in Exhibit "A" are definite and certain.

- (5) The boundaries of the territory do conform to lines of assessment and ownership.
 - (6) The territory includes 80 acres and is uninhabited.
- (7) The change of organization does not constitute a minor boundary change.
- (8) The territory proposed to be reorganized is hereby designated the "Mission Gorge Reorganization No. 2" (City of San Diego).
- (9) The Commission hereby designates the City of San Diego as the conducting authority and authorizes the City Council to initiate proceedings in compliance with this resolution without notice and hearing and without an election.
- (10) The Executive Officer of this Commission is directed to file and mail certified copies of this resolution as required by law.



- 2. Certificate Re: Terms & Conditions and Indebtedness (use attached form). Please return signed, original copy.
- 3. State Board of Equalization fee in the amount of \$\frac{320.00}{\text{(make checks payable to "State Board of Equalization").} \text{NOTE: Filings received in the LAFCO office after November 15 and to be filed by December 31 must include an additional 10%, as required by Section 3(f) of the State Board of Equalization Schedule of Processing Fees effective January 1, 1981.

The Executive Officer will check all documents for compliance before filings are made. Amendments to the LAFCO resolution, including boundary modifications, can only be made by the Commission. All documents recorded and copies of letters of acknowledgment will be returned to the conducting authority.
