RESOLUTION OF INTENTION TO ANNEX TO THE SAN DIEGO
OPEN SPACE PARK FACILITIES DISTRICT NO. 1 CERTAIN
TERRITORY IN THE COUNTY OF SAN DIEGO, STATE OF
CALIFORNIA, "MISSION GORGE REORGANIZATION NO. 2."

WHEREAS, the San Diego Open Space Park Facilities District
No. 1 was established by Council Resolution No. 220486 on March
20, 1978; and

WHEREAS, said district by the terms of the resolution
included all of the property within the boundaries of the City
of San Diego; and

WHEREAS, it is appropriate and desirable that said property
which has been annexed to The City of San Diego, be annexed to
the San Diego Open Space Park Facilities District No. 1; and

WHEREAS, Section 61.2070 of the San Diego Municipal Code of
The City of San Diego, provides for the annexation of property
to a park facilities district; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that its intention is hereby expressed to conduct a hearing
which will be held in the Council Chambers on the 12th Floor of
the City Administration Building, 202 "C" Street, San Diego,
California, on August 16, 1983, at 10:30 a.m., at which time the
Council will consider whether or not to annex the "Mission Gorge
Reorganization No. 2," as more particularly described in Exhibit
A attached hereto, to the Open Space Park Facilities District
No. 1.

BE IT FURTHER RESOLVED, that the owners of said property or any portion thereof may appear at the hearing and be heard, orally or by writing, signed by them, and may present evidence in support of or in opposition to the proposed annexation.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to post a copy of this resolution on the bulletin board of the City Administration Building and to cause a copy of this resolution to be published in the Daily Transcript once a week for two weeks prior to the hearing, the posting and first publication to be on or before the tenth day prior to the day of the hearing.

All that portion of Lot 6 in Block H of Fanita Rancho Revised in the City of Santee, County of San Diego, State of California, according to map thereof No. 688 filed in the County Recorder's Office of said county, lying within the following described boundaries:

Beginning at the most southerly corner of said Lot 6;

1. thence northwesterly and northerly along the boundary of said Lot to the southeasterly line of Road Survey No. 627 (60 feet wide) map on file in the County Engineer's Office of said county;
2. thence northeasterly along said southeasterly line and along the southeasterly line of Road Survey No. 627 (80 feet wide) to the westerly line of Tract "C" of Rancho El Cajon, according to partition map thereof, a copy of which is filed as Miscellaneous Map No. 278, on September 1, 1954, in said County Recorder's Office;
3. thence southerly along said westerly line to the southwest corner of said Tract "C";
4. thence north $88^{\circ}26'04''$ east, 801.20 feet along the southerly line of Tract "C", being also the northerly line of said Lot 6, Block H, to the easterly line of said Lot 6;
5. thence southerly along said easterly line to the POINT OF BEGINNING.
