BE IT RESOLVED, by the Council of The City of San Diego as follows:

WHEREAS, The City of San Diego is the owner of an easement for open space in the area of Lot 301 El Dorado Hills Unit 13; and

WHEREAS, the Property Department has requested that the City quitclaim to SHAPELL-LOMASANTAS PARTNERSHIP, a partnership, its interest in and to said easement; and

WHEREAS, the owner of the property wishes to clear title to his property; and

WHEREAS, the herein-described property is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City desires to negotiate the sale of said easement to SHAPELL-LOMASANTAS PARTNERSHIP, a partnership, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property, as determined by City staff appraisal is SIXTY-NINE THOUSAND DOLLARS (\$69,000); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That that certain easement for open space described in that quitclaim deed on file in the office of the City Clerk as Document No. RR- 258865 , be, and the same is hereby determined to be surplus and is hereby authorized to be sold by negotiation for the sum of SIXTY-NINE THOUSAND DOLLARS (\$69,000) to SHAPELL-LOMASANTAS PARTNERSHIP, a partnership.
- 2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No.

- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver the quitclaim deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
