BE IT FURTHER RESOLVED, that the transfer of funds from the Unallocated Reserve to cover payment of the State Board of Equalization fee of \$560.00 for costs associated with the "Lower Mission Gorge Reorganization," is hereby approved.

BE IT FURTHER RESOLVED, that the factors to be considered as designated in Paragraph 5 of Council Policy 600-1 are hereby waived.
