RESOLUTION NUMBER R- 258889  
Adopted on JUL 18 1983

WHEREAS, the City Council has caused to be prepared the Ocean Boulevard Master Plan; and

WHEREAS, in the preparation of said Master Plan several experimental programs were conducted to evaluate the long-range solutions to the traffic problems on Ocean Boulevard and recently occurring critical public safety problems that are causing hazards to members of the public using the beach and to public and private property; and

WHEREAS, there are alternate streets available for proper traffic circulation; and

WHEREAS, said Master Plan was reviewed at numerous public meetings by public and private committees and boards over a two-year period; and

WHEREAS, on October 11, 1982, the Council of The City of San Diego approved the Ocean Boulevard Master Plan recommending that vehicular travel be permanently prohibited on certain portions of Ocean Boulevard; and

WHEREAS, on November 18, 1982, the California Coastal Commission approved the permanent prohibition of vehicular travel on Ocean Boulevard from 150 feet south of Diamond Street to Garnet Avenue; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the authority vested in local authorities


pursuant to the provisions of California Vehicle Code Section 21101, Ocean Boulevard is hereby closed to vehicles from 150 feet south of Diamond Street to Garnet Avenue.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to implement further traffic flow measures incidental to said closing as may be necessary to remedy any related traffic flow problems.

BE IT FURTHER RESOLVED, that this resolution does not constitute a vacation of right-of-way and the City Council reserves the right at any time in the future to, at its discretion, reopen the street to motor vehicles.
