RESOLUTION OF THE CITY COUNCIL REGARDING ITS INTENTION TO DEDICATE, FOR PUBLIC RIGHT OF WAY, PORTIONS OF BROWN FIELD AND THE BROWN FIELD FILTRATION PLANT.

WHEREAS, The City of San Diego is, in cooperation with the County of San Diego, the State of California and the United States Government, constructing and improving portions of Otay Mesa Road; and

WHEREAS, the proposed improvements involve widening of Otay Mesa Road adjacent to both Brown Field and the Brown Field Filtration Plant; and

WHEREAS, the City of San Diego acquired title to Brown Field from the United States Navy with restrictions that the property be used for airport purposes; and

WHEREAS, the proposed improvements to Otay Mesa Road adjacent to Brown Field and the Filtration Plant will require dedication of portions of Brown Field and the Filtration Plant which are covered by the restrictions; and


WHEREAS, the City intends to use the parcels of land released from the restrictions for airport uses for purposes in furtherance of the transportation goals of federal, state, and local governments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council of San Diego declares that its intention to use, dedicate and hold for public street and highway purposes, those portions of Brown Field and the Brown Field

Filtration Plant, as more particularly shown on Document No.  
RR-258890, on file in the office of the City Clerk,  
subsequent to their release from any restrictions that may  
currently be imposed upon them for airport uses.
