
Adopted on JUL 25 1983

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street easement deeds of BILL R. KREDER, an unmarried man, and BOREGO ASSOCIATES, a general partnership, executed in favor of The City of San Diego, bearing dates of May 19, 1983, and April 29, 1983, respectively, copies of which deeds are on file in the Office of the City Clerk as Documents Nos. RR- 258928 -/ and RR- 258928-2, granting to said City easements for public street purposes in a portion of Parcel 2, Parcel Map 9982, and a portion of Lot 25, Beacon Hill, Map 1302, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named BEACON DRIVE and BOREGO STREET.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
