LEGAL DESCRIPTION

PARCEL 1: (R/W 23991-1)

An easement for road purposes in and to that portion of Pompeii Farms Company, Pompeii Subdivision, according to map thereof No. 1738, filed in the office of the County Recorder of San Diego County, September 19, 1922, including portions of the platted streets thereon, described as follows:

Commencing at the West quarter corner of Section 2, T.14S., R.2W., S.B.M., according to the official plat thereof; thence (1) along the Easterly line of said Pompeii Subdivision N.01° 17'14"E., 236.04 feet to the TRUE POINT OF BEGINNING; thence (2) leaving said Easterly line from a tangent which bears N.52° 49'45"W., along a curve to the left, with a radius of 2937 feet, through a central angle of 0° 11'26", an arc distance of 9.77 feet; thence (3) N.53° 01'11"W., 2234.01 feet to a point hereinafter referred to as Point "A"; thence (4) continuing N.53° 01'11"W., 724.76 feet to a point hereinafter referred to as Point "B"; thence (5) continuing N.53° 01'11"W., 851.14 feet to the Northerly line of said Pompeii Subdivision; thence (6) along said Northerly line S.88° 47'00"E., 215.59 feet; thence (7) leaving said Northerly line S.53° 01'11"E., 1241.59 feet to a point hereinafter referred to as Point "C"; thence (8) continuing S.53° 01'11"E., 2312.63 feet to said Easterly line; thence (9) along said Easterly line S.01° 17'14"W., 155.16 feet to the TRUE POINT OF BEGINNING.

PARCEL 2 (R/W 23990-1)

An easement for road purposes in and to those portions of Lots 1 and 2 in Section 34, T.13S., R.2W., S.B.M., according to the official plat thereof and that portion of Rancho San Bernardo according to Map thereof recorded in Book 2 Page 462 of Patents, records of San Diego County, all described as follows:

Commencing at the Southeast corner of said Section 34; thence (1) along the Southerly line of said Section 34, N.88° 47'00"W., 2886.93 feet to the TRUE POINT OF BEGINNING; thence (2) leaving said Southerly line, N.53° 01'11"W., 2471.03 feet; thence (3) S.36° 58'49"W., 63.00 feet; thence (4) S.53° 01'11"E., 115.00 feet; thence (5) S.36° 58'49"W., 63.00 feet; thence (6) S.53° 01'11"E., 2181.10 feet to said Southerly line; thence (7) along said Southerly line, S.88° 47'00"E., 215.59 feet to the TRUE POINT OF BEGINNING.
