## RESOLUTION NUMBER R- 258933 Adopted on JUL 25 1983

WHEREAS, the Redevelopment Agency of The City of San Diego ("Agency"), has undertaken certain redevelopment projects in the Centre City area; and

WHEREAS, the Agency has adopted budgets for those projects for Fiscal Year 1983-84, such budgets on file in the office of the City Clerk as Document No. 10/7, and in the office of the Secretary of the Agency as Document No. R868,869; and

WHEREAS, those budgets identify as revenue sources certain City funds including Three Hundred Thousand Dollars (\$300,000), of transient occupancy tax funds for the continued planning, legal, financial, and administrative activities relative to a new convention center facility; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That transient occupancy tax funds in the amount of Three Hundred Thousand Dollars (\$300,000) are hereby transferred from the New Convention Facility Fund No. 10225 to the Agency's Convention Center Fund No. 98730 to be utilized and expended for the planning activities for a new convention center facility in the Centre City area.
- 2. That the City Auditor and Comptroller is hereby authorized and directed to transfer such funds to the Agency.

- 3. That such contributions to the Agency are to be recorded as interest bearing loans to the Agency, repayable from tax increment revenues or other revenues.
- 4. That in the event that the Agency desires to issue bonds, notes, or other instruments of indebtedness of the Agency to carry out these redevelopment projects, then any indebtedness of the Agency to the City, including any interest accrued thereon, shall be deemed not to be a first pledge of tax increment allocations received by the Agency pursuant to Health and Safety Code, Section 33670; and any indebtedness of the Agency to the City, including any interest accrued thereon, shall be subordinate to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.
