WHEREAS, the San Diego Municipal Code provides for the establishment of Building Inspection Department fee schedules for sign permits by Council resolution; and


WHEREAS, copies of the proposed fee schedule and notice that a hearing would be held to consider said fees were sent to all identifiable members of the sign industry; and
