RESOLUTION CONSIDERING THE PROTESTS, ORDERING THE DISTRICT FORMED, CONFIRMING THE ASSESSMENT AND ORDERING THE PROPOSED MAINTENANCE IN THE MATTER OF THE PENASQUITOS EAST LANDSCAPE MAINTENANCE DISTRICT.

WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of THE PENASQUITOS EAST LANDSCAPE MAINTENANCE DISTRICT under Resolution of Intention No. R-258819, adopted JUL 05 1983, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The protests, if any, are overruled.
2. The District, the boundaries of which are described in said Resolution of Intention, is hereby ordered formed.

3. That except as provided in paragraph 4 of this resolution, the assessments described in Document No.


RR- 258819, on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved.

4. The maximum assessment per residential dwelling unit shall not exceed \$50 per year without the specific approval of this Council.
