RESOLUTION CONSIDERING THE PROTESTS, APPROVING THE ANNEXATION, CONFIRMING THE ASSESSMENT, APPROVING THE MODIFIED MAP, AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF THE SCRIPPS-MIRAMAR RANCH LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT


WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of the Scripps-Miramar Ranch Landscape and Lighting Maintenance Districts No. 1 and No. 2 under Resolution of Intention No. R- 258820 adopted JUL 5 1983, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The protests, if any, are overruled.
2. The assessments described in Document No. RR 258821, on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved.
3. The district formerly known as the Scripps-Miramar Lighting and Landscape Maintenance District No. 2 is hereby annexed to and is now a part of the Scripps-Miramar Lighting and Landscape Maintenance District No. 1.
4. The modified assessment district map for the Scripps-Miramar Ranch Landscape and Lighting Maintenance District described in Document No. 768718 is hereby approved.

5. The maintenance described in said Resolution of Intention is hereby ordered performed.
