APPROVING MAP OF
CARMEL VALLEY NEIGHBORHOOD 6 UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Robert C. Haynes, a registered Civil Engineer, entitled "CARMEL VALLEY NEIGHBORHOOD 6 UNIT NO. 1, being a subdivision of those portions of Parcel 1 of Parcel Map No. 11045, filed in the office of the County Recorder of San Diego, February 27, 1981 as file No. 81-060790 of Official Records and Parcel 2 of Parcel Map No. 8042, recorded November 10, 1978 as file No. 78-488017 of Official Records, all being in the City of San Diego, County of San Diego, State of California, and excepting therefrom an undivided 2/3 interest in all oil rights until September 15, 1993 as reserved by E. C. Batchelder and Maud Clark Batchelder and Ed Fletcher Company in deed recorded January 16, 1945 in Book 1798, page 357 Official Records," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Carmel Vista Road and Carmel View Road, together with pedestrian and non-motor vehicular right-of-way; and said streets are hereby declared to be public streets and public pedestrian and non-motor vehicular right-of-way and are dedicated to the public use, as dedicated

and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1, 2 and 3 of the Owner's Certificate, as shown on this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets and the pedestrian and non-motor vehicular right-of-way are accepted on behalf of the public as heretofore stated; and that those easements listed in paragraphs 1, 2 and 3 of the Owner's Certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
