

RESOLUTION NUMBER R- 258967


Adopted on AUG 1 1983

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street, drainage, slope and sewer easement deeds of VILLAGE PROPERTIES, a general partnership, dated July 7, 1983; PARDEE CONSTRUCTION COMPANY, a California corporation, dated March 9, 1983; and JOSEPH F. OLIVER and SUSAN MACK OLIVER, husband and wife, dated July 12, 1983; all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 258967-1, RR- 258967-2, RR- 258967-3, RR- 258967-4, RR- 258967-5, RR- 258967-6 and RR- 258967-7, granting to said City easements for public streets, drainage, slope and sewer purposes in Parcels 1 and 2 of Parcel Map No. 11045; Parcel 2 of Parcel Map 8042; Sections 19 and 30, T14S, R3W; and Sections 24 and 25, T14S, R4W, S.B.M., as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public streets is hereby dedicated as and for public streets and the same are hereby named CARMEL VIEW ROAD, EL CAMINO REAL, CARMEL VISTA ROAD, HIGH BLUFF DRIVE and CARMEL VALLEY ROAD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
