APPROVING MAP OF UNIVERSITY CANYON

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Don Nasland, a licensed Land Surveyor, entitled "UNIVERSITY CANYON, being a subdivision of Parcel 3 of Parcel Map No. 12838, in the City of San Diego, County of San Diego, State of California, according to map thereof filed in the office of the County Recorder of San Diego County, August 3, 1983," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Via Las Cumbres and pedestrian right-of-way; and said street is hereby declared to be a public street and pedestrian right-of-way and are dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, together with an emergency access easement, all as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for general utility purposes over, under, upon and across Lots 8, 12, 15, 22, 27 and portions of Lots 1, 9, 10, 13, 14, 26, 28, 39 and Parcel B, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for open space over, under, upon and across Lots 2, 3 and a portion of Lot 20, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and public pedestrian right-of-way are accepted on behalf of the public as heretofore stated; that the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, together with an emergency access easement as well as the general utility easements and the open space easements, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
