WHEREAS, the development of University Canyon subdivision requires the abandonment of an offsite sewer easement; and

WHEREAS, the sewer facilities will be relocated by the acceptance on this date of street and sewer easement deeds; and

WHEREAS, the sewer easement being abandoned is no longer required and will no longer serve the purpose for which it was acquired; and


WHEREAS, the City has no present or prospective public use for the sewer easement, and the City Manager has recommended that the City abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 258980 -/, quitclaiming to THE HOUSING COMMISSION OF THE CITY OF SAN DIEGO and THE UNIVERSITY OF SAN DIEGO, all the City's right, title and interest in the sewer easement, as more particularly described in said quitclaim deed.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
