WHEREAS, the Intergovernmental Relations Department ("IRD") has issued Report No. 83-50 dated July 12, 1983 regarding "Federal Legislation to Restrict Tax-Exempt Financing--HR 3110/HR 1635 (Pickle)" recommending that the City Council support HR 1635 and HR 3110 if they are amended to exempt waste-to-energy projects like SANDER; and
