
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a lease agreement with VIDEO SERVICES, INC., for a communications facility atop Cowles Mountain, at an initial annual rental of \$150,000, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 259015 .

BE IT FURTHER RESOLVED, that the proposed plans for screening the communications facility, required under the terms of the lease agreement, shall be submitted to and approved by the Public Facilities and Recreation Committee of the City Council prior to installation.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed not to execute the lease agreement unless and until existing disagreements between the City and the County regarding the use of the subject property and regarding the City's right to enter into the lease are resolved.
