RESOLUTION NUMBER R- 259026
Adopted on AUG 08 1983

WHEREAS, Section 8330, et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets and public service easements by City Council resolution where a portion of a street or highway lies within property under one ownership and does not continue through such ownership or end touching property of another; and

WHEREAS, the abutting property owners have requested the vacation of Hartford Street north of Clairemont Drive adjacent to Lots 15-28, Block 104, Morena Map 809, and Lots 3-6, Clairemont Court Subdivision, Map 2861; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Hartford Street north of Clairemont Drive adjacent to Lots 15-28, Block 104, Morena Map 809, and Lots 3-6, Clairemont Court Subdivision Map 2861, as more particularly shown on Drawing No. 15801-B on file in the office of the City

Clerk as Document No. RR- ~~259026~~¹, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

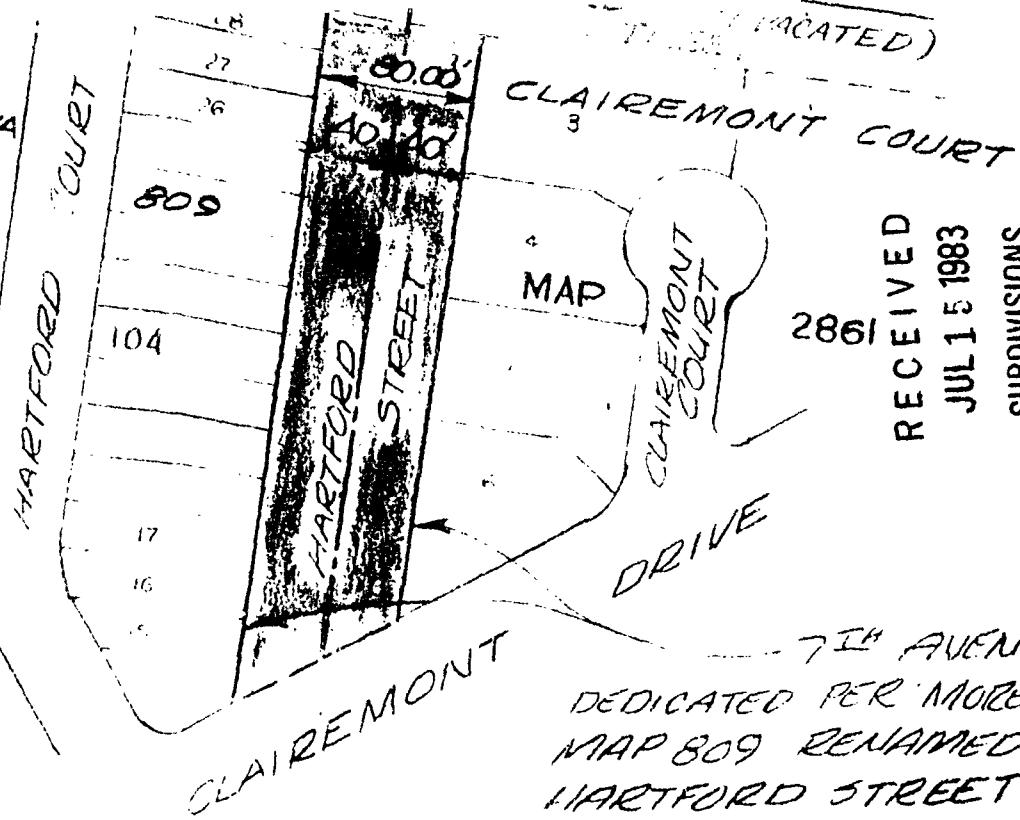

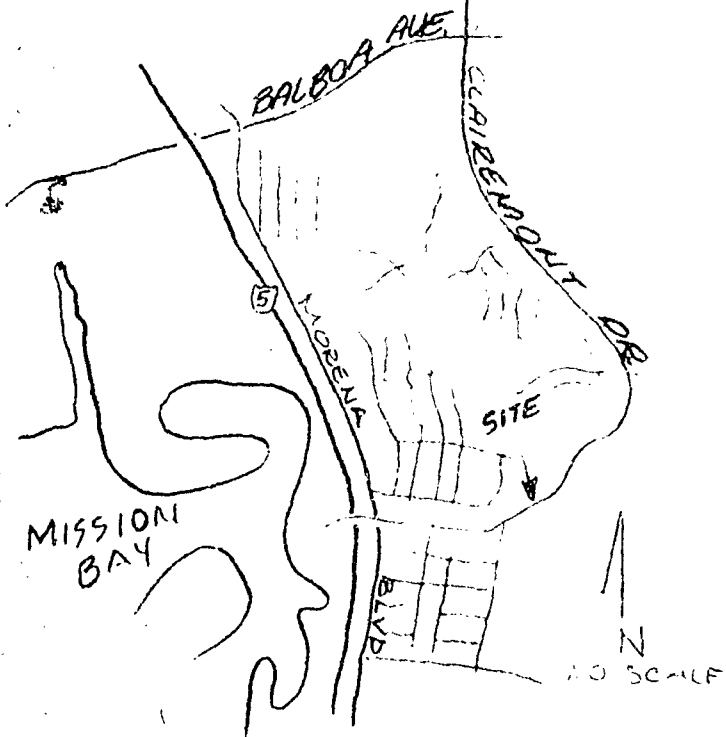
