
BE IT RESOLVED, by the Council of The City of San Diego as follows:

NEWBERRY, executed in favor of The City of San Diego, bearing date of January 21, 1983, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- **259029 -1**, granting to said City an easement for public street purposes in a portion of the northerly half of the Northeasterly Quarter of Quarter Section 79 of Rancho de la Nacion, Map 166, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named VARNEY DRIVE.

BE IT FURTHER RESOLVED, that the acceptance by the City Manager of that deed of HELEN O. NEWBERRY, executed in favor of The City of San Diego, bearing date of January 21, 1983, granting to City an irrevocable offer for a street reservation and slope easement in a portion of the northerly half of the Northeasterly Quarter of Quarter Section 79 of Rancho de la Nacion, Map 166, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. RR- **259029 -2**, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
