WHEREAS, the enforcement of said restrictions is conducted by agreement with the County Department of Animal Control; and

WHEREAS, the latest requirements to be incorporated in said agreement requires the execution of a Fourth Supplemental Agreement to the Basic Agreement for Animal Regulation Service; and

WHEREAS, the County has confirmed that it can continue the current level of enforcement, as required; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized to execute, for and on behalf of said City, a FOURTH SUPPLEMENTAL AGREEMENT TO THE BASIC AGREEMENT for Animal Regulation Service with the County of San Diego, at a cost not to exceed \$148,489, pursuant to the terms and conditions of that certain FOURTH SUPPLEMENTAL AGREEMENT TO THE BASIC AGREEMENT on file in the office of the City Clerk as Document No. RE-259033.
