BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Utilities Agreement No. 24788 with the STATE DEPARTMENT OF TRANSPORTATION for relocation of water facilities as part of a highway project to relocate Camino Del Rio South at the interchange of Route 8 and Route 15 (on Road 11-SD-15, R5.6-R6.5, between 0.4 mile south and 0.5 mile north of Route 8), under the terms and conditions set forth in Utilities Agreement No. 24788 on file in the office of the City Clerk as Document No. RR-
259036.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$32,840 from CIP 73-024 "Annual Allocation--Freeway Relocation," Water Revenue Fund 41502, for depreciation credits, is hereby authorized, solely and exclusively for the above purpose.

BE IT FURTHER RESOLVED, that the expenditure of \$20,390 for preliminary engineering (reimbursable by the State) is hereby authorized.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City Forces all the water main work as required in connection with the relocation of water facilities, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be

done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$16,000 (reimbursable by the State).
