BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City Forces all the water main work as required in connection with the relocation of water facilities, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be

done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$16,000 (reimbursable by the State).
