
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a 20-year lease agreement with SAN DIEGO CHARGERS, for the purpose of construction and operation of administrative offices at San Diego Jack Murphy Stadium, at an initial monthly rental of \$1,674, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 259037.

BE IT FURTHER RESOLVED, that a rent credit in the amount of not to exceed \$33,814 for the cost of improvements to be made by Chargers, to be applied over the first 20 months of the agreement, is hereby approved.
