That the expenditure of an amount not to exceed \$180,000 of Capital Outlay Funds from CIP project 37-250 for such professional services and related costs, is hereby authorized and approved.

That the City Manager is hereby authorized to coordinate any matters related to site assessment plan development, approval and execution with the County, State and other regulatory agencies, as appropriate.
