BE IT RESOLVED, by the Council of The City of San Diego as follows:



BE IT FURTHER RESOLVED, that the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by July 1, 1984, as provided by the amendment to the subdivision agreement on file in the office of the City Clerk as Document No. RR-259068.

BE IT FURTHER RESOLVED, that Performance Bond No. OC-300490, in the amount of \$100,000.00, issued by FREMONT INDEMNITY COMPANY, is hereby accepted as the surety for the required improvements in said subdivision, and that Performance Bond No. 8ST 341 541, in the amount of \$2,456,964.00, issued by LUMBERMEN'S MUTUAL CASUALTY COMPANY, is hereby released.
