

That the City Manager be and he is hereby authorized and empowered to pay the total sum of \$1,497,500.00 in the settlement of Superior Court Case No. 464152, Monica Michele Ginger v. The City of San Diego, et al., and of each and every claim against The City of San Diego, its agents and employees resulting from personal injuries of Monica Michele Ginger.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$1,497,500.00, made payable to MICHAEL GINGER AND LYDIA GINGER AS CONSERVATORS OF THE PERSON AND ESTATE OF MONICA MICHELE GINGER AND DAVID S. CASEY, JR., THEIR ATTORNEY OF RECORD, in full and final settlement of the lawsuit and of all claims.
