RESOLUTION NUMBER R- 259136

Adopted on AUG 22 1983

WHEREAS, when the Governor vetoed over \$600 million from California's FY 84 Budget, state expenditures were reduced sufficiently to partially restore the subventions local government lost in the legislatively adopted budget; and

WHEREAS, for this money to be available, two legislative acts requiring a two-thirds vote in each house must take place in August; first, the deflator must be suspended and second, \$617 million in reduced subventions must be restored or a new revenue source enacted; and

WHEREAS, the budget trailer bill (AB 223) allows the AB 8 deflator to trigger on October 1; and

WHEREAS, if the deflator is not suspended, the total loss to cities, counties and special districts is \$965 million in subvention reductions rather than the \$348 million contemplated by local agencies; and

WHEREAS, the City of San Diego's subvention loss will total \$20.5 million, approximately \$8.5 million more than anticipated when the City's FY '84 Budget was adopted, if the deflator is not suspended; and


WHEREAS, on August 1, 1983, the Rules Committee considered a recommendation supporting suspension of the AB 8 deflator as set forth in IRD Report No. 83-57 and recommends approval by the full Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
that this Council supports suspension of the AB 8 deflator  
effective October 1, 1983.

BE IT FURTHER RESOLVED, that the Legislature is urged to  
restore local governments' subventions so that the statewide  
loss does not exceed \$348 million.
