BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for


TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$41,000.00 from Park Service District Fund 11340 to CIP No. 23-590.4 TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$41,000.00 from Park Service District Fund 11340, CIP No. 23-590.4 TIERRASANTA COMMUNITY PARK ADDITIONAL IMPROVEMENTS, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
