

RESOLUTION No. R-259161 (R-84-281)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That all bids theretofore received on June 7, 1983, pursuant to publication of notice calling for bids on CONSTRUCTION OF CIVIC THEATRE LIGHTING CONTROL SYSTEM are hereby rejected; and
2. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF CIVIC THEATRE LIGHTING CONTROL SYSTEM filed in the office of the City Clerk of the City of San Diego, California, on SEP 12 1983, and bearing official Document No. W.D. 118147, be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for CONSTRUCTION OF CIVIC THEATRE LIGHTING CONTROL SYSTEM, San Diego, California.


BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$19,999.77 from Convention and Performing Arts Center Fund 10320 to CIP No. 34-042 CIVIC THEATRE LIGHTING CONTROL BOOTH.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$287,500.00 from Convention and Performing Arts Center Fund 10320, CIP No. 34-042 CIVIC THEATRE LIGHTING CONTROL BOOTH is hereby authorized to supplement funds previously authorized by Resolution No. R-258402, adopted on May 9, 1983 for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego, be and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
