

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and drainage easement deeds of PONDEROSA HOMES, a California partnership, dated May 8, 1981; HELIX LAND CO. LTD. and HELIX 1960, LTD., dated March 10, 1982; and THE SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, dated May 13, 1981, all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents Nos. RR- 259183 -1 , RR- 259183 -2 , RR- 259183 -3 and RR- 259183 -4 , granting to said City easements for a public street and drainage purposes in a portion of the Southwest Quarter of Section 32, Township 14 South, Range 2 West, San Bernardino Meridian, and a portion of Lot 8 in Scripps Miramar Ranch Business Park, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named SCRIPPS RANCH BOULEVARD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
