RESOLUTION NUMBER R- 259193

Adopted on SEP 12 1983

WHEREAS, small business plays a significant role in the economic growth and vitality of San Diego economy; and

WHEREAS, any serious commitment to job creation in San Diego must involve a set of strategies designed for small business which will facilitate their expansion and help prevent job loss due to business failure which could be avoided; and

WHEREAS, in San Diego, a wide variety of federal, state and local resources are available to small businesses and persons interested in starting small businesses, however, no comprehensive assistance program has been available to help San Diego business owners review all these opportunities at a single location, select the resources they need, and package them in the most beneficial manner; and

WHEREAS, Assemblyman Katz, Chairman of the Assembly Select Committee on Small Business, is sponsoring a package of legislation designed to assist California's two million small businesses; and

WHEREAS, this legislation would provide for statewide coordination of centers and create advocacy programs for the small business community; and

WHEREAS, the Mayor, in a memorandum dated August 15, 1983, submitted to the Rules Committee a series of recommendations in regard to the proposed legislation; and

WHEREAS, the Mayor recommended, among other things, the support and inclusion in the City's legislative program of the three bills proposed by Assemblyman Katz to assist small businesses; and

WHEREAS, on August 15, 1983, the Rules Committee considered those recommendations contained in the Mayor's memorandum, approved them unanimously, and now recommends approval by the full Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Director of Intergovernmental Relations be and he is hereby directed to include in The City of San Diego's legislative program the following legislation:

AB 1651 (Katz) Small Business Development Centers

AB 1652 (Katz) Secondary Market for Small Business Loans

AB 1592 (Katz) California Small Business Office of Advocacy

BE IT FURTHER RESOLVED, that the City's legislative representative be and he is hereby directed to actively support the above cited bills.

BE IT FURTHER RESOLVED, that the Director of Intergovernmental Relations be and he is hereby directed to report to the Rules Committee, as needed, on the status of the above cited bills.
