BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.06 of the San Diego Municipal Code, the PARKING OF VEHICLES IS HEREBY PROHIBITED AT ALL TIMES DAILY on and along both sides of the following streets in said City:

FAIRMOUNT AVENUE from Interstate 8 to Montezuma Road; MONTEZUMA ROAD from Fairmount Avenue to 55th Street excepting the south side from Collwood Boulevard to a point 200 feet easterly; 55TH STREET from Montezuma Road to Remington Road; and REMINGTON ROAD from 55th Street to Hewlett Drive.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized and directed to be made on said streets to prohibit parking of vehicles to permit the establishment of bicycle lanes, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
